Course description:

The main objective of this course is to acquaint students with the basic issues of European philosophy and culture in order to get a picture of the idea of Europe. Secondly, to develop a proper way of freethinking based on analogies, debates and analytical comparisons focused on the main theoretical themes in European history and culture. The course is designated to introduce the undergraduate students to some major issues of European history and philosophy which may give an account of what does it mean to be an European. In the first term the stress will be on the following topics: I. Greek cosmos; II. Medieval divine cosmos; III. Modern secular thought; IV. Contract, rights, individualism. We will consider the texts both as contributions to the understanding of specific historical and cultural events, as well as attempt to analyze the relationship between different cultural assumptions. Is it possible to create a sort of "theoretical bridge" between conflicting values and cultural identities?

Seminar / Laboratory / Project description:

The topics covered by the seminars will be split into three main objectives:

a) historical case studies;

b) text analyze and interpretation.

c) presentation and exposure of the major masterpieces of European culture and philosophy. Students will finally have a full account of what ones may call "the European man".

Intended learning outcomes:

Students will develop abilities to operate with the major concepts and theoretical roots which have been crucial for developing a cultural European identity. They will also improve their skills for

critical thinking and appraisal of some controversial issues in European culture, politics, and society. Finally they would better deal with the various challenges raised by their professional integration in an Europe of continuous integration and des-integration.
